#### Minutes

#### **Treasurer's Report**

Lynn Chapman, Treasurer, requested that the amount credited to the General Fund from entry fees be adjusted from \$1.55 to either \$1.50 or \$1.60 to simplify payouts and bookkeeping. Following discussion, a motion was made, seconded, and approved to reduce the amount credited to the General Fund from each entry fee to \$1.50, and the Standing Rules will be amended to reflect this change.

#### Tournaments

Cathy Woodburne, Tournament Chair, raised the following issues for discussion based upon questions and concerns she has received this year:

• Can you qualify for the Championship by playing Team five days prior to the Championship?

The consensus was that "yes" you can as long as the member has, additionally, met the requirement of posting five cards at her home course.

• Can you qualify for the Championship by playing nine holes in a tournament (quitting due to weather) when your score cannot be posted as a tournament?

The consensus was that this circumstance would only count if the competition in the tournament was Eccie 9.

• Would the Board and City Reps like to consider some other competition (such as Mutt and Jeff or ONES) rather than the Pro Am since there was such a low turn-out this year?

The consensus was that the members still want to have a Pro Am but the location of where it's held needs more consideration..
